The Firehouse is required to meet the Airports goals including but not limited to LEED v4 Gold, expanded SFO sustainability requirements, Fine Arts Commission Approvals, PUC Commissioning requirements, REACH Goals, SFO TI standards, SFO system standards, Essential Services Act, project phasing, NFPA 1581 and SF ESER equivalent for fire station design standards.
